SECTION A COMMUNICATION

1. Read the following passage and answer the questions that follow.

Import substitution industrialisation in Africa has been dominated by multinational corporations and resulted in industries highly dependent on imports, mere assembly plants, mostly consumer-goods enterprises with very low value added. Their heavy reliance on foreign exchange for imported inputs, forces these industries to shut down or operate at very low capacity utilization during shortages of foreign exchange.

The failure of this import-substitution industrialization strategy with its textile first approach, emphasizing consumer-goods production, dictates the need for an alternative industrialization strategy.

The de-industrialization strategy of the International Monetary Fund and World Bank's Structural Adjustment Programme is equally untenable. By striving for effective leverage over the industrial policy of debtor countries, Structural Adjustment Programme insists falsely that African countries should concentrate on the export promotion of raw materials and de-emphasize manufacturing because these countries are said to have comparative advantage only in the production of primary products.

But this is a facile and imperialist strategy for arresting the industrialization of African countries in order to ensure cheap supply of raw materials to the advanced countries and prevent Third World industries from competing with the industrial exports of the imperialist countries.

The alternative industrial strategy must be basically inward looking and self-reliant, both nationally and collectively. It should strive primarily to satisfy domestic demand for manufactured goods and be based mainly on local resources. Its starting point is an assessment of the domestic demand for critical manufactured goods like processed food, drugs, chemicals, shoes, vehicles and educational materials, then intermediate products like cement, roofing sheets, paints, insecticides, fertilizers, tractors and steel for agriculture, construction and industrial basic capital goods like machine tools, petro-chemicals, machinery and transport equipment. These intermediate and capital goods may be expensive for small African countries to manufacture locally and so they can be produced within cooperative schemes on a sub-regional basis.

Local resources of manpower, capital and raw materials under local sourcing should provide the dominant inputs for the manufacturing of these critical products. African experts should be mobilized to identify different possible uses for local raw materials and the inventory should be publicized to the business community and researchers.

In this way manufacturing based on local resources such as agro-allied industries and petroleum-based manufacturing can provide a major catalyst for manufacturing. Forward and backward integration or linkages can then be developed to expand local industries. Small scale enterprises, then should receive special emphasis in this alternative strategy, though they are

labour intensive, but can be effective against unemployment and their artisan technology offers an excellent opportunity for the democratization of technology.
