## SECTION A COMMUNICATION

1. Read the following passage and answer the questions that follow:

In an effort to update their economies, developing countries mainly rely on the machinery and technology transferred to them from the industrialized world and adjusted to the specific local conditions under which the national economies operate.

The transfer of technology is a broad notion which implies that developing nations not only bring in the advanced equipment and know-how from abroad, but also adapt new work ethics, including managerial and marketing skills, which provide for the efficient use of the transferred machinery and technology. What they also need is trained personnel and technical staff and the access to world market.

Developing countries are in a permanent need for the latest technologies, thus making the owners of those technologies to take advantage of the situation hence derive high profits. To buy the patents, licences, trademarks and invite foreign experts, developing countries have to pay the Western Corporations an ever increasing part of their hard currency receipts.

By accepting these terms, the developing countries cannot proceed along the road to progress independently. They are obliged to regularly renew purchases from the same Transnational Corporations from which the technology was originally bought. Quite often they are compelled to buy the technology which does not meet their requirements, damages nature and depend on imported raw and subsidiary materials and spare parts.
