	c) Dictatorship government is the type of government which comes into power by force and does onsider democratic elections.
I	Effects
	It does not observe the rule of law, the ruler or dictator is above the laws and is the one who makes ions for everything.

It does not respect human rights; the human rights such as freedom of press, freedom of speech etc are violated by the rulers. Rulers or dictator abuses power means there must be existence of corruption, interference in other organs such as judiciary and legislature. d) Child preference is an attitude by some parents that certain gender of children is more desirable than others. **Effects** It may cause conflict in a family. It may lead to breakup of the family. It may cause a psychological problem to a child due to the feeling that he or she is not loved by the parents because of her/his sex. It may make a child run away from home and can become the street child, becoming a prostitute and engaging in drug abuse. e) Drug abuse is a self-administration of drug like cocaine, marijuana etc on -medical reasons in quantities and frequencies which impair an individuals ability. function effectively and which may result in social, physical or external harm. **Effects** It increases the rate of crimes like theft, murder and prostitution It leads to low productivity at work places

It results to mental disorder and makes the victim restless.

f) Human rights abuse Is any action that violates human rights which can be thought as ignorance, negligence, corruption, child labour, etc.

Effects

It causes poor attendance of students in schools due to child labour in wars, mining, fishing and prostitution.

I It diminishes other people access to human rights e.g. equal treatment before the law is impossible due to corruption.

I It may cause strikes and violence at work places if the workers are deprived of their rights by employers. Inheritance of widows, FGM, rape, etc. may speed up the spread of HIV/AIDS in the society.

g) Road accidents Road Is unpleasant events that happen on or along the roads unexpectedly and cause death, injury and damage to properties and infrastructure.

Effects

They cause death, permanent disability, injury and damage to properties and infrastructure.

They cause family suffering due to permanent disability of victims of accidents. Such disabled person may be unable to work causing the economic decline of the family.

The government, private individuals and organizations will have to spend a lot of money on medical treatment of their beloved ones and maintenance of properties and infrastructure.

Accidents also may cause a delay in arriving at our destinations such as schools, work places, mosques, churches and homes.

h) Improper behaviour Is a kind of behaviour which is not morally acceptable to the family, community and society e.g. theft, prostitution, corruption, etc.
Effects
Improper behaviour increases the rate of crimes like robbery, pro son, rape, corruption, etc.
It may cause divorce or separation of couples which can leads to the disintegration.
Improper behaviour may speed up the spread of HIV/AIDS ampng the young people. i) Step family is the family that is formed when somebody marries a person who already has children.
Effects
It may lead to street children if father or mother mistreats those children.
It may speed up the spread of HIV/AIDS if one marries an infected person.
Children will not have love, care and respect from both parents.
Children may not get rights like right to education and other important rights. j) Women inheritance is a type of marriage in which a widow marries a kinsman of her late husband, often his brother.
Effects

It speeds the spread of diseases especially HIV/AIDS

It may lead to the loss of right to own properties such as land and other properties she owned with her husband.

It causes separation of families in which it can make children leave their homes and become street children.

6. The national constitution is the system which establishes fundamental rules and principles by which a nation or country is governed.

importance of national constitution can be explained as follows:-

It lays down the basis structure of the government according to how people are to be governed.

It defines the power and makes clear divisions of responsibilities of each organ of the state i.e. executive, judiciary and legislature.

It is the mother law of the land and it lays out the principles for governing a country. This means that all laws are derived from it.

It gives direction for an effective government and lays down the limitations of the power of the government officials.

It provides for the national goals and fundamental principles on which the nation rests upon.

It safeguards and guarantees the rights, liberties of the citizens and duties of citizens as well.
